Commitment to CMMC 2.0 Level 2 Compliance

Key Milestones in Our CMMC Compliance Journey:

1. Gap Analysis and Remediation Planning (Completed by Q3 2024):

- Contracted an accredited C3PAO (CMMC Third-Party Assessment Organization) to provide a readiness assessment of the CIS controls framework v8 NIST800-171 v2 (CMMC)
- The C3PAO conducted a thorough gap analysis to identify areas where our current security policies, practices, and controls align with, and where they need to be enhanced for compliance.
- Based on this analysis, we have developed a comprehensive plan to address any identified gaps.

2. Implementation of Required Controls (Estimated Completion Q3 2025):

- Implementing a formal cybersecurity risk management and governance program.
- Training per our security awareness program schedule.
- Testing and monitoring the physical and technical controls.
- Updating organizational policies and procedures.
- Enhancing incident response workflows.

3. Pre-Assessment of Center for Internet Security (CIS) Controls (Estimated Completion for Q3 2025):

- Contracted a leading cybersecurity firm to:
 - Conduct a CIS controls-based and security posture analysis.
 - Document a threat focused risk register.
 - Create a risk treatment roadmap.
 - Create a governance program for sustainability of our security program.

4. Official CMMC 2.0 Level 2 Assessment:

 We plan to schedule our formal CMMC 2.0 Level 2 assessment with an accredited C3PAO (CMMC Third-Party Assessment Organization) based on current government timeline guidance.
